Special Note:-

The said Pre School in either case shall be entitled to the payment of this onetime benefit, only in the event of confirmation of the admission and receipt of any 1 (one) complete installment from parents excluding the discounted installment and same is not being cancelled within 90 (Ninety) days thereafter by the student of the said Pre School and/or parents of such students. No other or additional claims with respect to any other expenses including but not limited to out-of-pocket expenses shall be entertained and permitted unless EIPL and /or the said Licensed Part(ies) has expressly consented in writing to such charges.

However, parents can only avail the offers/benefits enlisted in Annexure A above and no other offers/benefits offered by the School(s) in respect of the admission(s) can be selected/opted by such parents. Furthermore, if parents approach for refund of installment due to cancellation of admission, then the paid onetime benefit amount to the Pre School shall either be refunded or to be adjusted against future payable onetime benefit amount, at the discretion of EIPL.

It is further clarified that the Offers/Benefits under this MOU shall be subject to change/modification/revision at the sole discretion of EIPL.

b) Purpose of the MOU

Both the Parties have entered into this MOU with an intention that it may lead to admission of students of the said Pre-School with the schools run by EIPL and /or the said Licensed Part(ies).

c) Independent Contractor Status

Nothing herein shall be deemed or construed to create a joint venture, partnership, employee/employer, principal / agent or Franchisor- Franchisee or any other relationship between the Parties for any purpose.

d) Assistance to be provided by VIBGYOR

i) **EIPL** and /or the said Licensed Part(ies) will facilitate offering priority counseling for students studying in the said Pre - School. However, it is agreed and understood that admissions to **VIBGYOR** are solely subject to availability of seats in that academic year and following the norms, policies, rules and regulations governing the admission criteria of **VIBGYOR**. Admission shall be ensured by **EIPL** and /or the said Licensed Part(ies) and those are subject to seat availability, final decision of **EIPL** and /or the said Licensed Part(ies). The said Pre-School shall not make any such commitments to

its students and their parents and in case of any disputes due to such issues, it shall solely on its cost and consequences sort the issue and keep **EIPL** and /or the said Licensed Part(ies), its Directors, employees indemnified from any consequences, complaints, Orders, penalties levied by any authority or third parties or the parents or students arising due to false commitments made by the said Pre-School.

- ii) **EIPL** and /or the said Licensed Part(ies) will organize Admissions information sessions for parents of children at the said Pre-School or at the premises of either of the school on a prefixed date and time as agreed upon by both the Parties.
- iii) **EIPL** and /or the said Licensed Part(ies) will invite children and parents of the said Pre-School to drive – '**Buddy Day**' at **VIBGYOR**.
- iv) **EIPL** and /or the said Licensed Part(ies) will allow the said Pre-School to use its infrastructure such as classroom, assembly halls in one of the premises managed by **EIPL** and /or the said Licensed Part(ies) to organize school events such as annual day /sports day, subject to availability, at no cost. Any other requirements for e.g. food & beverage will be charged at a mutually agreed prefixed cost. The said Pre-School agrees to compensate **EIPL** and /or the said Licensed Part(ies) for any damage/loss caused to its property whilst the same is being used/operated by the said Pre-School and/or its appointed employees.
- v) **EIPL** and /or the said Licensed Part(ies) will provide the said Pre-School a certificate of association that is to be displayed by the said Pre-School prominently at a conspicuous place in its school premises and it should be readable and visible to all outsiders from reasonable distance.
- vi) **EIPL** and /or the said Licensed Part(ies) states that it has its unique 'Inter VIBGYOR Transfer' facility which will be of immense benefit and interest to the kids attending the said Pre-School whose parents have transferable jobs. With a network of 36 schools across 13 cities and its unique synchronous curriculum model, **EIPL** and /or the said Licensed Part(ies) facilitates a seamless transfer of the student from one VIBGYOR location to another without interruption or discontinuity of curriculum. - i) The said Pre-School will inform parents that the admissions in VIBGYOR are subject to availability of seats in that academic year and as per the admission process.
- ii) The said Pre-School may organize school visits by bringing their students to a mutually agreed centre of **EIPL** and /or the said Licensed Part(ies) as part of activity mentioned in their curriculum '**Big School Visit**.
- iii) The said Pre-School will organize at least 2 (two) admission information sessions basis mutual understanding and prior discussion and notify **EIPL** and /or the said Licensed Part(ies) of the same.

- iv) The said Pre-School shall not make any commitment, representation or undertaking to any Parents and/or any third party on behalf of **EIPL** and /or the said Licensed Part(ies), without the prior written consent of **EIPL** and /or the said Licensed Part(ies).
- v) The said Pre-School shall not use or infringe the trademark or logo or any other Intellectual property rights of **EIPL**.
- vi) The said Pre-School shall not be entitled to assign, sub-contract any of its rights under this MOU to any third party without the prior written consent of **EIPL** and /or the said Licensed Part(ies).
- vii) They shall not conduct any activity which shall directly or indirectly be in conflict of interest with the working of **EIPL** and /or the said Licensed Part(ies).

f) Confidentiality and Non Disclosure

It is understood that both **EIPL** and /or the said Licensed Part(ies) and the said Pre-School shall protect and preserve the confidentiality and secrecy of the confidential information, disclosed by either Party to other, in writing, during the term of MOU and same confidentiality shall be maintained even after termination of this MOU. They shall not, at any time during or after the Term, disclose or communicate to any other third party all or any of the confidential information, data in any manner whatsoever. In case of any breach or violation of the confidentiality term by either Party, the other Party shall be entitled to claim liquidated damages from the Party committing the breach or violation.

g) Intellectual property

During the course of this arrangement, **EIPL** and /or the said Licensed Part(ies) may share materials and resources with the said Pre-School which are proprietary information of **EIPL** and /or the said Licensed Part(ies) and in which it may also hold intellectual property rights. It is hereby agreed by the said Pre-School that such proprietary information including the Intellectual property shall always remain as the property and under ownership of **EIPL** and /or the said Licensed Part(ies) and that nothing in this arrangement shall affect its ownership. The said Pre-School shall not use or infringe in any manner **EIPL** and /or the said Licensed Part(ies)'s name, trademark or logo or any other Intellectual Property Rights.

h) **Termination**

Either Party shall hold the right to terminate this MOU before its expiry by tendering 15 (Fifteen) days prior written notice. Upon such termination by either of the Parties, (i) The said Pre-School shall not be entitled to claim any compensation for loss of

business/profit from **EIPL** and /or the said Licensed Part(ies) (ii) The said Pre-School shall hand over all the assets and materials provided by **EIPL** and /or the said Licensed Part(ies) to them including all the records maintained by them to the authorized representative of **EIPL** and /or the said Licensed Part(ies) without any demur, objection and protests. All indemnities provided under this MOU shall survive termination.

i) Notice

Any notice required or permitted to be given by either party to the other shall be in writing. Unless otherwise specified by a Party in writing. All notices shall be duly addressed to the other party at the address provided hereinabove. Such notice shall be effected either: (a) personally, in which case service shall be deemed effective on delivery; or (b) by pre-paid registered post, or (c) registered post with AD/speed post with AD/fax/E mail/courier in which case service will be deemed effective on the day after posting.

j) Communication

Any communication from either Party to the other Party shall be addressed in writing as per the details more particularly mentioned hereunder:

This MOU is made on a non-exclusive, non-binding manner and is a tie up for preschool educational entities to have access of quality education for the students studying in their institutions and does not create any business relationship.

l) Governing Law & Jurisdiction

This MOU will be construed in accordance with and governed by the Laws of India and each Party agrees to submit to the exclusive jurisdiction of the courts in the city of Mumbai, India.

m) Amendment / Additions/ Modifications

Any amendment / additions/ modifications with respect to these presents shall be effected only in writing which is executed by both the Parties and shall be deemed to constitute as an integral part of these presents.

n) Non Solicitation

During the subsistence of this MOU and for a further period of twelve (12) months thereafter neither the said Pre-School nor **EIPL** and /or the said Licensed Part(ies) shall either directly or indirectly, without the prior written consent of the other party, solicit the services of or make an offer of employment to, or hire any person who is an employee or a consultant of the other Party at the time of such solicitation, offer or hire or has been an employee on any date during a period of six (6) months prior to such solicitation, offer or hire.

o) **Indemnity**

In performing services under this MOU, the said Pre-School agrees to indemnify, defend, and hold **EIPL** and /or the said Licensed Part(ies), its officers, directors, members, employees, representatives, agents, and the like saved & harmless for any alleged or actual infringement and for any liability, debt, or claim, expense or damage or other obligation arising out of or as a result of or relating to (a) the MOU, (b) the performance of the MOU, or (c) the deliverables.

This indemnification shall include all legal expenses including the Advocates fees incurred by VIBGYOR shall be borne and paid by the said Pre-School

p) Custody Of MOU

This MOU will be executed in counterparts. Each counterpart shall be treated and considered as an original and such counterpart shall together constitute one and the same document i.e. MOU. Therefore, both Parties hereto shall retain one original executed MOU with them.
